Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Section 3 Additional Notices

On the following holidays, we only offer transportation services from the place of pickup to our facility, our other services are not available. These days include: New Years Eve, New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, Christmas Eve and Christmas Day.

Final disposition via natural organic reduction cannot be performed with arrangements that include embalming. Renew does not require or offer embalming or cremation as part of our arrangements for natural organic reduction.

Payment terms to licensed funeral professionals are sixty (60) days of receipt of the invoice with signed NOR Services Agreement with Renew. Fees are subject to change without notice.

We invite our clients to visit our facility and review our policies and procedures at any time. We also ask that our clients conduct two or more unannounced formal inspections of our facility per year. This is part of our "Best Practices and Transparency Guarantee." **Due to the industrial nature of our facility, family visits and services are by appointment only.**

Section 4 Packaged Services

Natural Organic Reduction Package

\$3,500

This fee includes services to prepare the decedent for final disposition via natural organic reduction. This does not include the transport of the decedent, death certificate and permit processing, or the mailing, delivery or scattering of reduced remains.

- **Our services includes:** (1) basic services of funeral director and staff, including a proportionate share of overhead costs, (2) alternative container, (3) refrigeration of the body for 48 hours after removal or receipt of the decedent at our facility, (4) natural organic reduction service, (5) soil testing, (6) storage of reduced remains for 48 hours at our facility.

Section 5 Non-declinable Costs and Services

Basic Services of Funeral Director and Staff and Overhead

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for natural organic reduction.

Section 6 Itemized Costs and Services

Transport of Decedent

Itemized

This fee includes removal from the place of pickup to our facility. If Renew holds a decedent at our facility after a transport, a transport fee will apply to transport the decedent to another location. This fee is itemized per county, per one and two technician removal, in **Section 8**.

- **Long Distance Transport:** This fee includes our services for removal distances not itemized per county in **Section 8**. **\$100 + \$3.50/mile**
- **Removal Cancellation:** This fee is for cancellation of removal request. **60% of rate**
- **Additional Technician:** This fee is for an additional removal technician. **20% of rate**

Mailing of Partial Reduced Remains

\$50 + USPS postage

This fee includes services to prepare and package partial reduced remains in accordance with USPS guidelines, tendering at a USPS location, cash advance of postage, and tracking information.

Delivery of Full Reduced Remains

Itemized

This fee includes services to deliver from our facility to the designated recipient of reduced remains. This fee is itemized per county in **Section 8**.

Section 6 Itemized Costs and Services (continued)

Scattering of Reduced Remains	\$100
--------------------------------------	--------------

This fee includes services to scatter reduced remains by hand on private property in Clackamas County, including location reporting to vital statistics.

Use of Facilities and Staff for Viewing	\$295
--	--------------

This fee includes use of a private room at our facility for viewing of the decedent by the immediate family. The viewing is limited to a maximum of 2 hours total.

Use of Facilities and Staff for Memorial Service	\$295
---	--------------

This fee includes the use of a private room at our facility and staff member operation of associated technology for conducting and transmitting a virtual memorial service to the immediate family. The memorial service is limited to a maximum of 2 hours total.

Witnessed Tuck-in Service	\$295
----------------------------------	--------------

This fee includes services to arrange and accommodate access for the immediate family of a decedent to witness the laying in (tuck-in) of the decedent at our facility. The service is limited to a maximum of 2 hours total.

Refrigeration of the Body	\$15/day
----------------------------------	-----------------

This fee includes refrigeration of the body at our facility, starting 48 hours after removal or receipt of the decedent at our facility. The body is refrigerated in preparation for final disposition.

Storage of Reduced Remains	\$50/day
-----------------------------------	-----------------

This fee includes storage of the reduced remains at our facility, starting 48 hours upon completion of final disposition via natural organic reduction.

Other Preparation of the Body	Itemized
--------------------------------------	-----------------

This fee includes services to prepare the deceased for final disposition. This does not include the embalming of human remains.

Caskets

Itemized

This fee includes services to provide a temporary casket container for the refrigeration of the decedent before final disposition.

- **Alternative Container:** This fee includes our services for providing a temporary corrugated tray, head block and white plastic shroud for refrigeration before final disposition. **\$15/each**
- **Combination Unit:** This fee includes our services for providing a temporary wooden tray, head block and white plastic shroud for refrigeration before final disposition. **\$205/each**
- **Air Tray:** This fee includes our services for providing a temporary oversized wooden tray, head block and white plastic shroud for refrigeration before final disposition. **\$235/each**

Urns

Itemized

This fee includes services to provide a temporary urn container for the reduced remains of the decedent after final disposition.

- **White Paper Box Urn:** This fee includes our services for providing a 1.5" x 1.5" x 3" urn for reduced remains. **\$8/each**
- **Rigid Black Plastic Container:** This fee includes our services for providing a plastic container for reduced remains. **\$15/each**
- **Biodegradable Urn:** This fee includes our services for providing a biodegradable urn for reduced remains. **\$150/each**
- **5-gallon Bucket:** This fee includes our services for providing a 5-gallon bucket for reduced remains. **\$15/each**
- **Small Corrugated Cube:** This fee includes our services for providing a 6" x 6" x 6" corrugated cube for reduced remains. **\$8/each**
